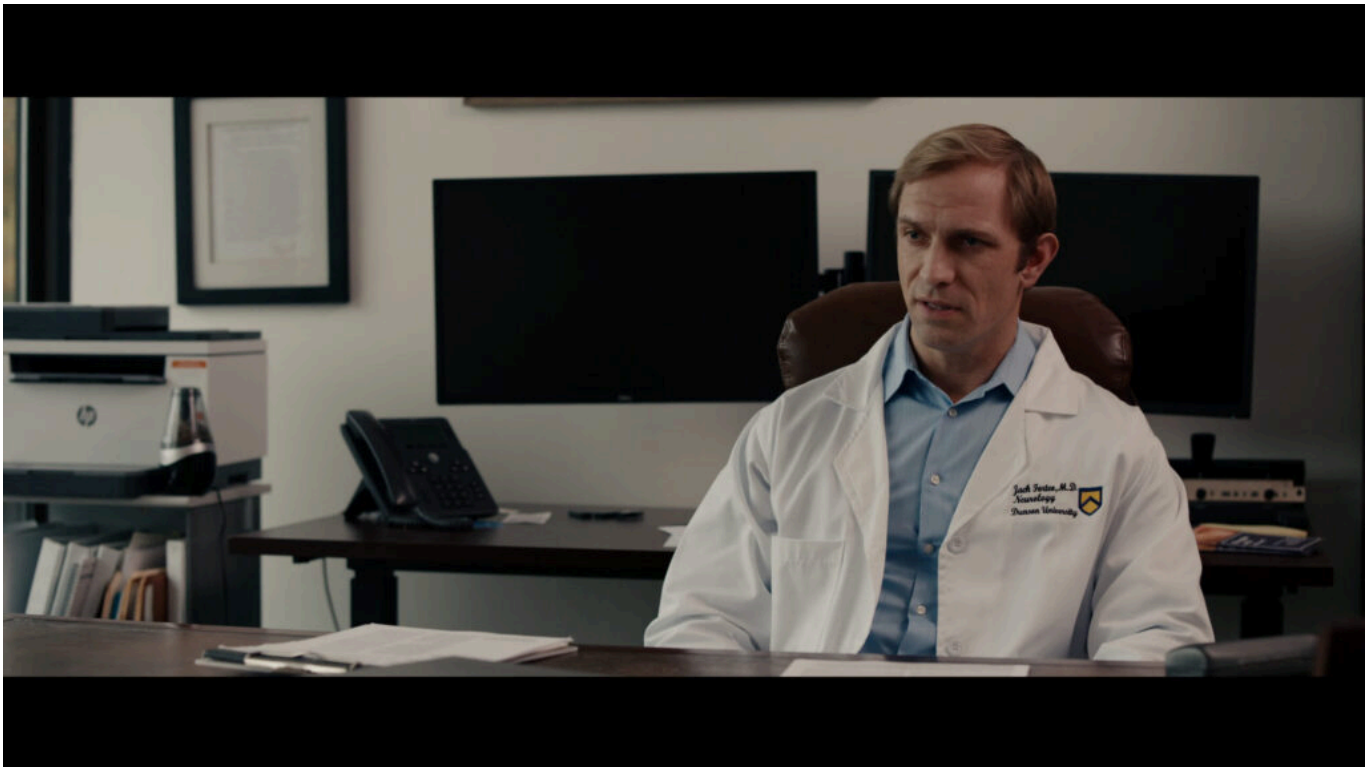


Red Leghorn in court. Played by [David de Vries](#).

Jack is played by **Andy Evans**.



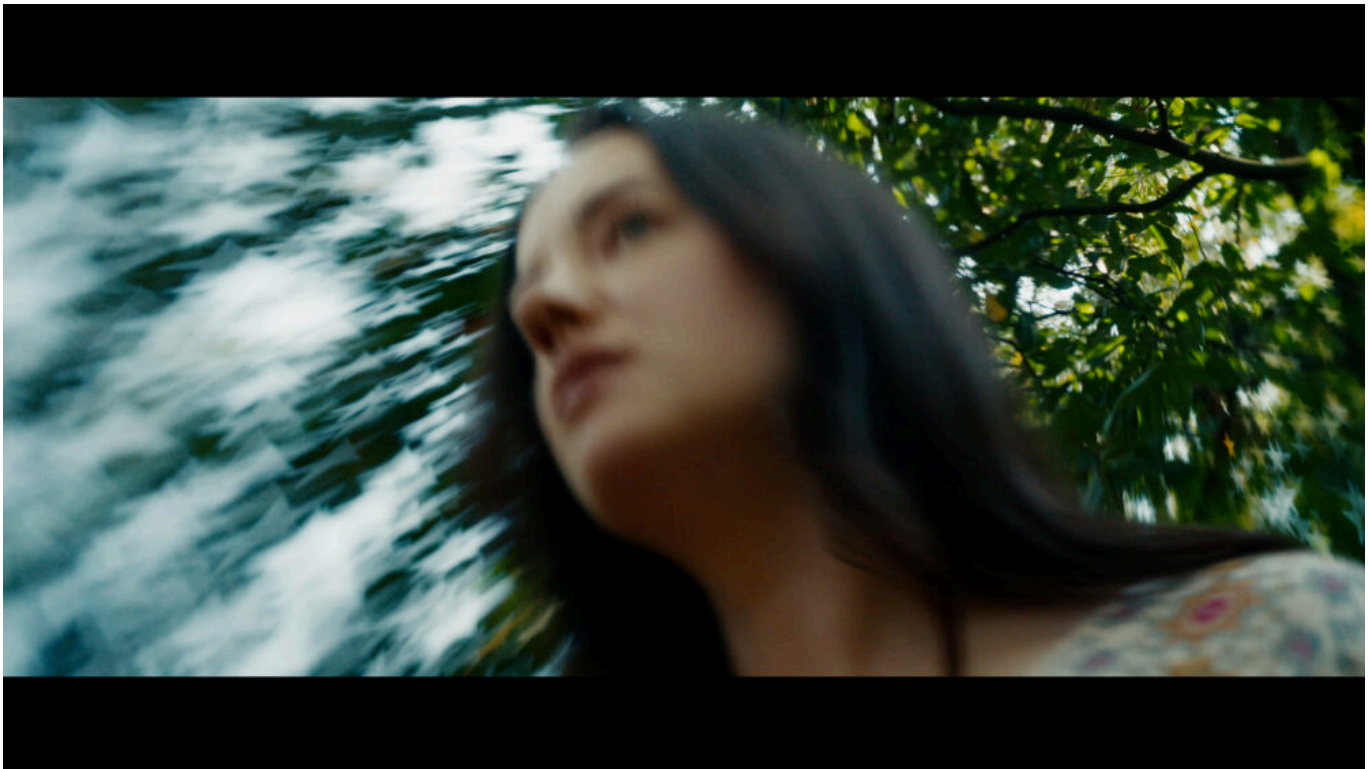
Ryan Singh is co-counsel for the plaintiffs. He is played by **Shaan Sharma** (*The Chosen*).



Crystal Watson is counsel for the defense, played by **Nisey Woods** (*Vampire Diaries*). She gives Jack a run for his money.



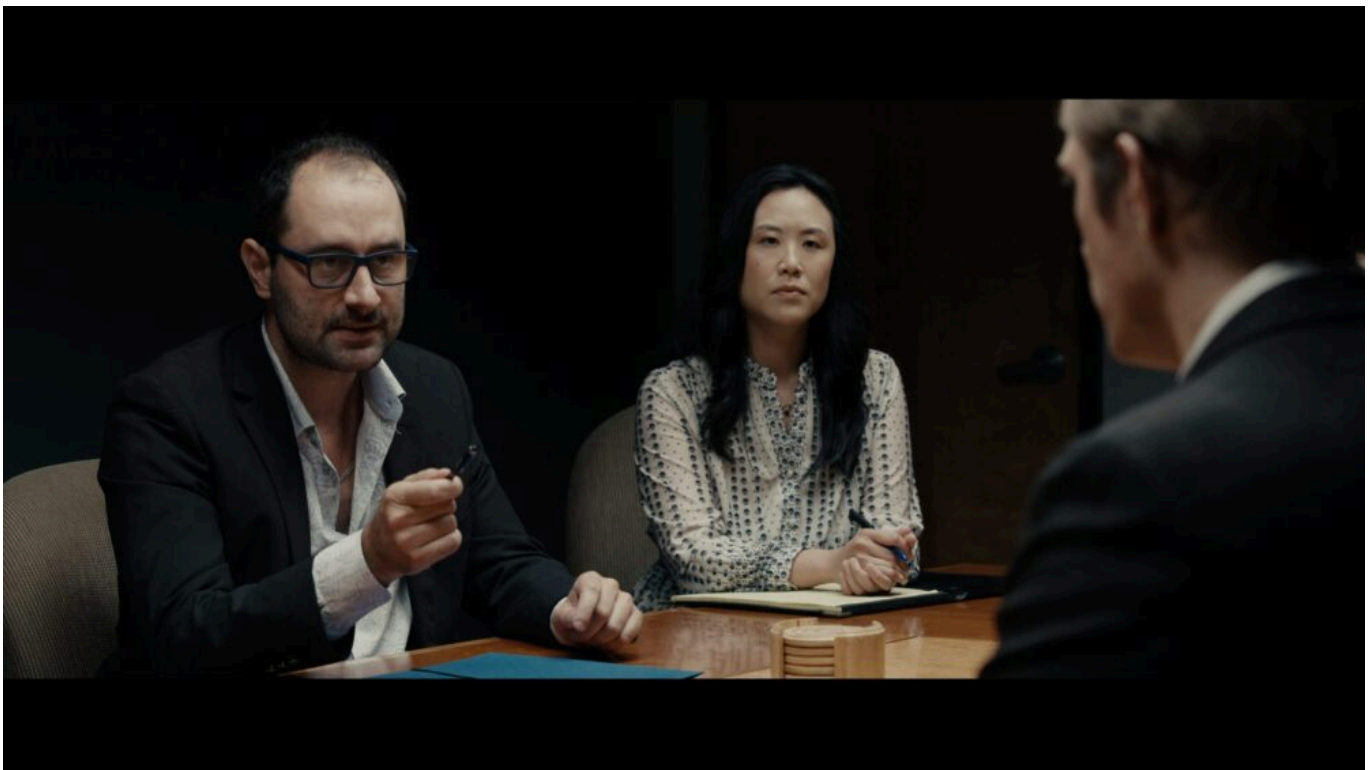
Jack's wife, Isabella Forte, supports him as tensions rise and the case progresses. Played by [Caroline Avery Granger](#).



Jack dreams of his dead mother, played by [Malone Thomas](#).

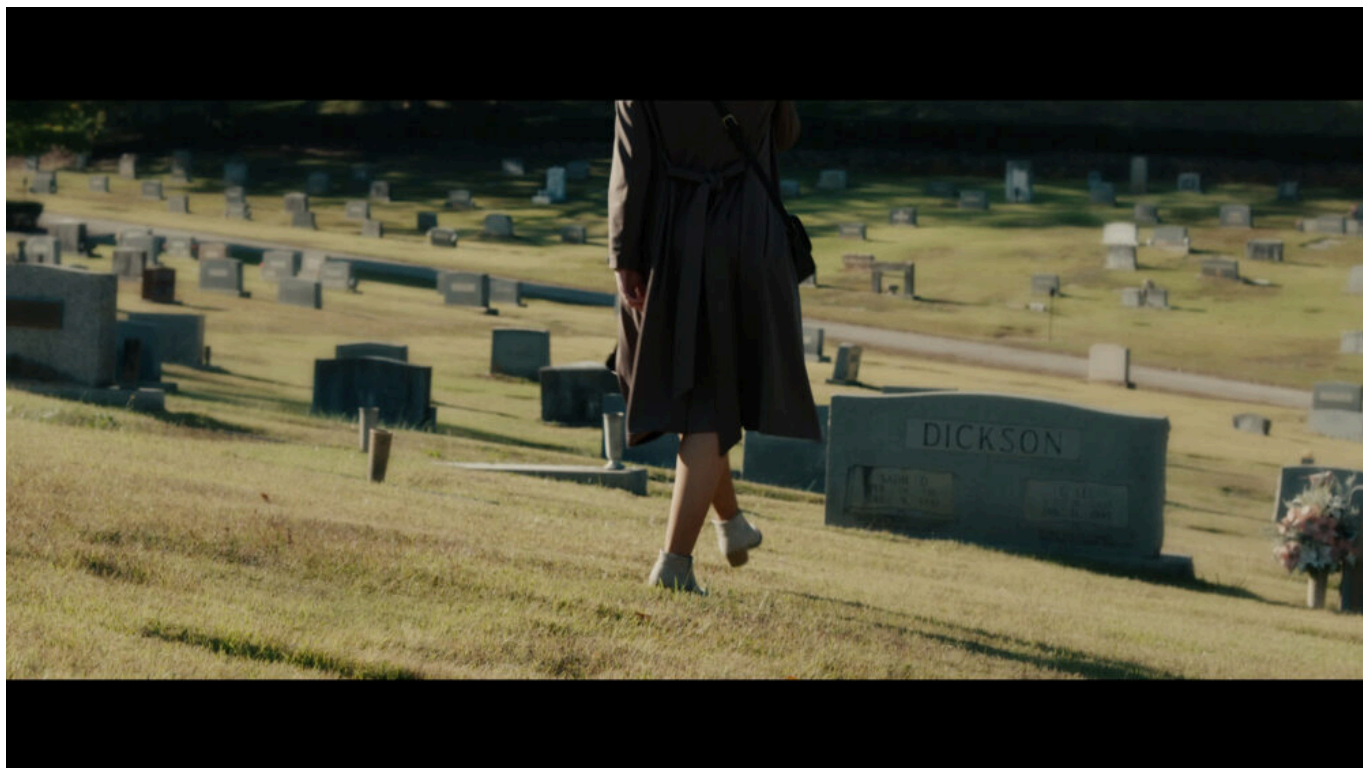
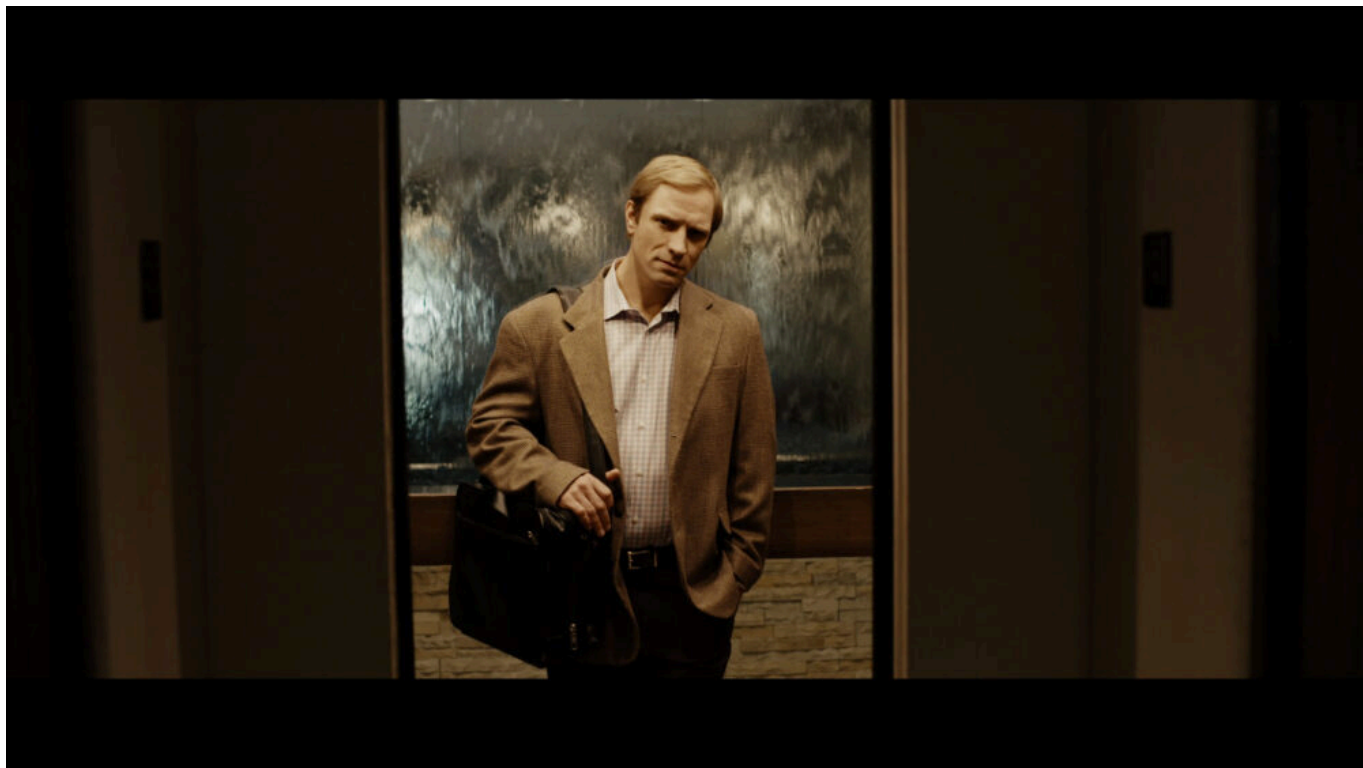
